

SUMMARY ANNUAL REPORT

For NEXCARE HEALTH SYSTEMS, LLC RETIREMENT SAVINGS PLAN

This is a summary of the annual report for NEXCARE HEALTH SYSTEMS, LLC RETIREMENT SAVINGS PLAN, EIN 38-3378353, Plan No. 001, for period January 01, 2010 through December 31, 2010. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$762,671. These expenses included \$77,695 in administrative expenses, and \$684,976 in benefits paid to participants and beneficiaries. A total of 2,157 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$7,920,464 as of December 31, 2010, compared to \$6,509,455 as of January 01, 2010. During the plan year the plan experienced an increase in its net assets of \$1,411,009. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$2,173,680, including employer contributions of \$254,535, employee contributions of \$1,058,668, and earnings from investments of \$860,477.

The plan has a contract with JOHN HANCOCK USA which allocates funds toward variable annuity contract. The total premiums paid for the plan year ending December 31, 2010 were \$0.

The charge to cover copying costs given above does not include a charge for the copying of these
